### PRODUCT PMP DECK MUD

#### DESCRIPTION

PMP Deck Mud is a dry, factory blended mortar specifically designed for use by tile and masonry contractors. The product is a preblended mix of washed plaster and Type II/V cement. Preblending allows the cement to thoroughly coat the sand particles thus producing a stronger than jobsite mix. The mortar bed is compatible with cement based and most water based latex adhesives. Standard mix design is 4:1 by weight. Special mix designs available.

#### USES

PMP Deck Mud is a leveling mortar underlayment for all types of pavers, tile and marble on floors and countertops.

#### ADVANTAGES

#### COVERAŒ

One 75 lb. bag will yield approximately 9.6 square feet at 1" thickness.

#### **TECHNICAL DATA**

PMP Deck Mud conforms to the volume composition for floor applications of ANSI A108.1A 2.2., IBC and CBC Table 2103.11, CBC Table 2103A.11, and L.A City approval RR# 24968.



#### APPLICATIONS

Mix PMP Deck Mud with only enough clean, potable water to form a ball when compacted in your hands. Compact and screed into place. Allow for proper cure prior to application of an adhesives. Do not try to accelerate cure with fans. Bonding mortar should be tested for suitability with PMP Deck Mud. Do not use epoxy mortars without the manufacturer cure time and compatibility concerns.

#### LIMITATIONS

- Do not apply when temperature is below or may fall below 40°F prior to curing
- Do not over water or over mix
- Do not accelerate curing time with fans
- Consult manufacturer prior to using epoxy bonding mortars.
